RE: Impact of COVID-19 Pandemic on Nebraska Dental Health Community

The DHHS Office of Oral Health and Dentistry is closely monitoring the current COVID-19 situation in Nebraska and communicating directly with DHHS Officials, the Nebraska Dental Association, the U.S. Public Health Service and the Association of State and Territorial Dental Directors. We are also in contact with the Nebraska Dental Schools, Community Health Centers and Local Public Health Departments.

The American Dental Association (ADA) released a bulletin on 16 March 2020 ADA News stating "the ADA recommends dentists nationwide postpone elective procedures for the next three weeks and concentrate on emergency dental care to alleviate the burden on hospital emergency departments. It is up to dentists to make well-informed decisions about their patients and practices." Please find updates and further information from the ADA at ADA.org/virus.

The Nebraska Dental Association (NDA) released a similar recommendation on 16 March 2020 (https://www.nedental.org/) along with guidelines for patient screening and proper infection control practices. The Nebraska Board of Dentistry issued a statement on 20 March 2020 in support of the ADA and NDA recommendations and defined emergent/essential dental care. The Chief Dental Officer for the U.S. Public Health Service, Rear Admiral Tim Ricks DMD, MPH recommends following Centers for Disease Control and Prevention (CDC) guidance on their website (COVID-19). The CDC is currently developing guidelines for COVID-19 in Dental Settings that should be released soon and available here: CDC.

The Nebraska Department of Health and Human Services (DHHS) released a COVID-19 general information guide on 16 March 2020 (DHHS COVID-19 Information).
